



**LONG TERM AGREEMENT FOR INSURANCE POLICIES ARRANGED

- (b) Changes in risk (including changes in locations and sums insured) are permitted. In such circumstances Insurance Corporation will allow a discount of seven and a half per cent from the premium(s) otherwise calculated
- (c) This agreement does not apply to premiums charged for any Terrorism buy-back cover
